### Permit Requirements:

1. Operation is permitted on private property and the City sidewalk in front of the business
2. \*\*\*Outdoor Hours of Operation Limited to 8:00 a.m. to 10:00 p.m.\*\*\*
3. Permittee shall provide for cleaning of the permitted encroachment area as well as the property
4. Permittee shall provide for refuse disposal
5. Permittee shall comply with all other provisions of their existing Conditional Use Permit, Health Department requirements, ABC licensing, and all other State & County requirements
6. Alcohol Service
  - a. No alcohol service or consumption outdoors without amended ABC license on file with the City of South El Monte and;
  - b. Consumption shall occur only within the confines of the physical establishment or within the permitted encroachment area.
7. Valid insurance must be on file with the City of South El Monte if operating on the sidewalk (coverage shall include \$1M per occurrence and \$2M aggregate)
8. Restaurants shall adhere to LA County Health Department Reopening & Outdoor Dining Protocols
9. Salons and barber shops shall adhere to LA County Health Department Reopening Protocols
10. Permission is granted by City and Property Owner to operate the established business as depicted on the attached site plan (generally: an extension of the existing business' boundary perpendicular to the designated sidewalk, preserving pedestrian access on the sidewalk)
11. Attached conditions must be adhered to at all times while operating under this permit
12. Operation shall comply with all City conditions of approval as may be imposed

13. Failure to follow permit requirements and guidelines may result in revocation of this permit

**Hold Harmless:** The undersigned shall save, keep, hold, and represent the City of South El Monte, its officers and agents harmless from all damages, costs or expenses in law, equity, and any liability that may at any time arise or be set up because of damages to property, or of personal injury received by reason of or in the course of performing work which may arise from or be a result of the involvement of the undersigned in the proposed temporary use.
