

RESOLUTION NO. 88-2860

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTH EL MONTE DECLARING THAT THERE IS A NEED FOR A PARKING AUTHORITY TO FUNCTION IN THE CITY AND DECLARING THE CITY COUNCIL TO BE THE BOARD OF DIRECTORS OF THE PARKING AUTHORITY.

R E C I T A L S

A. The City of South El Monte currently has inadequate facilities for public parking in commercial and other areas of the City which has led to excessive and disruptive on-street parking in adjacent residential areas.

B. The Parking Law of 1949 provides various methods pursuant to which a Parking Authority within a city may establish, furnish, acquire, construct, maintain and operate public parking facilities.

THEREFORE, THE CITY COUNCIL OF THE CITY OF SOUTH EL MONTE DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:

Section 1. Pursuant to Section 32651 of the California Streets and Highways Code, the City Council of the City of South El Monte hereby declares that there is a need for a Parking Authority to function in the City of South El Monte.

Section 2. Pursuant to Section 32650 of the California Streets and Highways Code, the name of the Parking Authority shall be the "Parking Authority of the City of South El Monte" which is and shall be a public body corporate and politic. The legislative body of the Parking Authority shall be known as the Board of Directors and an individual member thereof shall be known as a Director.

Section 3. The City Council of the City of South El Monte hereby declares itself to be the Board of Directors of the Parking Authority of the City of South El Monte pursuant to the authority granted by Section 32661.1 of the Streets and Highways Code. Accordingly, all the rights, powers, duties, privileges and immunities created by the Parking Law of 1949 (Sections 32500 et seq. of the California Streets and Highways Code) shall be vested in the City Council of the City of South El Monte as the Board of Directors of the Parking Authority of the City of South El Monte.

Section 4. The City Clerk shall certify to the adoption of this Resolution, and shall cause this Resolution and her certification to be entered in the Book of Resolutions of the City Council of the City of South El Monte and the Book of Resolutions of the Parking Authority of the City of South El Monte.


